Dear Essex Partnership University NHS Foundation Trust, to assist with my research into carbon reduction, please can the Trust answer the following questions?

- 1. Does your organisation have a Manage Print Strategy?

  No, EPUT does not currently have a manage print strategy
- 2. Does the Trust have a Digital Strategy?
  Yes
- 3. What IT projects over the last few years have had a focus or a main objective of reducing Carbon Footprint?

None with the main objective of reducing carbon footprint.

- 4. How many single function printers does The Trust have? In excess of 800
- 5. What brand are they? **HP**, **Xerox and Brother**
- 6. How many MFDs / photocopiers does The Trust have what brand are they? The trust has 139 Ricoh MFDs
- 7. When did the print contracts start? The contract starts 01/10/2024
- 8. When did the print contracts end? Contract ends 30/09/2029
- 9. Is there any option to extend this contract?
  Yes
- 10. Was this procured using a Gvt framework, if so which one? Crown Commercial Services RM6174
- 11. What digitation projects have happened / are planned to reduce print? A live efficiency programme is underway to reduce print with the ambition of leveraging digital technology to remove paper forms, to consolidate print hardware and strengthen policy on print appropriateness.



- 12. Approximately how much does the Trust spend annually on Print?

  Spend in the last financial year on our managed print service contract totals £168k which includes rental and charges for printing. We are unable to separate the 2 charges.
- 13. Approximately how many pages does the Trust print annually? We do not hold that information
- 14. Does The Trust use a print management solution to assist with controlling print volumes and costs? If so which one?

We do not use a print management solution on non-MFD printers

- 25. Currently does the Trust cross charge internally for print? **There is no cross charging for printing.**
- 26. Which department holds the Trust print budget?

  The budget is devolved out to the service lines to manage.
