[MFDs are all leased and the Trust is charged a cost-per-click, and service charges on the MFDs, not on printers.](#)

[The Trust has 333 printers](#)
10. What is the annual spend on printers – including lease costs, consumables, costs per click and service charges?  
[The Trust only purchase printers. MFDs are all leased and the Trust is charged a cost-per-click, and service charges on the MFDs, not on printers. Printers are purchased outright and we do have a consumable cost for these which was calculated as £250,170 including vat on printer consumables. Consumables for the photocopiers are included in the rental costs.](#)

[The Trust can only capture the print volumes from our MFDs as this information is](#)

collected via remote monitoring software. The printers are not attached to this software so the information would need to be extracted from each individual device throughout the Trust and exceed the time and cost limits, as set out in the Act. The Trust is therefore applying Section 12 of the Act (where cost of compliance exceeds appropriate limit. The volumes are:

Mono prints on MFDs – 2,572,418  
Colour prints on MFDs – 2,968,256

Applied Exemption:

**Section 12 (Exemption where cost of compliance exceeds appropriate limit):**

- (1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.
- (2) Subsection (1) does not exempt the public authority from its obligation to comply with paragraph (a) of section 1(1) unless the estimated cost of complying with that paragraph alone would exceed the appropriate limit.
- (3) In subsections (1) and (2) “the appropriate limit” means such amount as may be prescribed, and different amounts may be prescribed in relation to different cases.
- (4) The Secretary of State may by regulations provide that, in such circumstances as may be prescribed, where two or more requests for information are made to a public authority—
  - (a) by one person, or
  - (b) by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign, the estimated cost of complying with any of the requests is to be taken to be the estimated total cost of complying with all of them.
- (5) The Secretary of State may by regulations make provision for the purposes of this section as to the costs to be estimated and as to the manner in which they are to be estimated
